- The public artwork will embody a Welcome to Country for Gadigal land, waters and sky. This sculptural artwork will be made from natural materials that are found on Gadigal Country.
- This Expression of Interest includes your design and an outline of your concept.
- Three shortlisted Artists will be invited to discuss their design with the Selection Panel.
- The successful Artist will undertake consultation with Gadigal Traditional Custodians and BGoS to finalise their design for production.
- Following final approval, the Artist will produce their design by 12 May 2024, for installation in the entrance garden at the front of Botanic Gardens of Sydney headquarters on Mrs Macquaries Road, Royal Botanic Garden Sydney.
