The AGM is an opportunity to hear an update on the work of the Foundation & Friends and the Botanic Gardens of Sydney, as well as meet the Board, staff, volunteers and other members. The new Chief Executive of the Botanic Gardens of Sydney, Simon Duffy, will be guest speaker.

We look forward to welcoming you at the AGM.

The Nominations and Remuneration Committee has the task of finding suitable nominees for our Board. They are continually reviewing the skills and experiences represented on the Board to ensure balance as well as alignment with our vision and strategy. This year there are three vacancies on the Board.

Over the past eight months the Nominations and Remuneration Committee undertook a broad recruitment process for the vacant positions, including calling for expressions of interest from the membership. We thank all those that participated in the selection process.

Retiring members of the Board of Directors

In April, Jenny Lourey resigned from the Board, and we acknowledge her commitment of over 8 years, including as Chair of the Business Committee and Deputy Chair of the Board.

After an incredible 12 years of service, Clive Austin's term comes to an end at this year's AGM. We acknowledge Clive's immeasurable commitment, including 6 years as Chair, and his thoughtful contribution and continuous support of the Gardens. Foundation & Friends would not be in the position it is without the insightful and guiding hand of Clive.

Another long-term Board member standing down at the AGM after 11 years of service is Matthew Glascott. Matt has brought his commercial networks and skills to the organisation and played a pivotal role in many of our unique events and activities, including the much-loved Garden Design Series.

Appointment of members to the Board of Directors

Jenny's resignation in April left a casual vacancy on the Board, and on recommendation from the Nominations and Remuneration Committee, the Board was pleased to appoint Kristine Anderson to the Board in June. Kris has been a member of our Development Committee and comes with a wealth of fundraising and non-profit experience to support our strategy. As Kris filled a casual vacancy, her current term ends at the AGM.

The Board received and reviewed the recommendations from the Nominations and Remuneration Committee for the three vacant positions to the Board. Details of the selected nominees can be found at the end of this notice.
